Shelter Plus Care - supportive housing program providing rental subsidies and case management for homeless people disabled by mental illness.

Pathways Projects - integrates housing and employment support services for households with a history of homelessness and a disabling condition. The program includes rental subsidies, service planning, job-readiness training, employment placement assistance, case management, referrals to treatment, and other community services.

Homeless emergency services - available 24 hours a day, 365 days a year to make sure that everyone who comes to HATAS for help will have a safe place to sleep that night:

24-Hour Homeless Emergency Services Program - central intake, assessment, and referral point for homeless Albany County residents needing shelter.

After-Hours Heating Emergency Assistance Program - responds to after-hours fuel and heating assistance requests made by low-income Albany County residents.

Supportive Housing - provides supported housing to homeless individuals and families.

Homelessness Prevention and Rapid Re-housing - provides financial and case management resources targeting low-income City of Albany residents facing eviction.

Mental health:

Community Transition Team - work with hospital and Albany County Department of Mental Health (ACDMH) on discharge planning for hospital patients.

Aging Out Adolescent Program - work with ACDMH helping adolescents "aging out" of children's mental health system make the transition to adult services.

Albany HANDS - mental health/criminal justice program for homeless and "at-risk" non-violent offenders living with mental illness and substance abuse disorders.

Shelter Plus Care - supportive housing program providing rental subsidies and case management for homeless people disabled by mental illness.
